CANCELLATIONS:

Cancellations must be made by 5PM on last business day before sale, or there WILL BE a \$10.00 cancellation fee.

UNCLAIMED VEHICLES:

Any vehicle not removed from the property within 7 days will be towed and stored AT THE OWNERS EXPENSE!!

ALL VEHICLES REGISTERED HERE ARE SUBJECT TO INSPECTION BY THE STATE POLICE, FBI, OR THE NATIONAL AUTO THEFT BUREAU. VEHICLES WITHOUT A VALID VIN PLATE **WILL NOT BE RAN!**

HOW TO BUY:

1. You may inspect the vehicles on the outside lot before they are auctioned. Keys are handed out until 6:45 pm only. See office for keys.
2. You have approximately 2 minutes to bid on vehicles once they enter the auction lane. BE FAMILIAR WITH THE LIGHTING SYSTEM.
3. Subject to seller's approval, the last bidder is the absolute buyer!
4. Proceed IMMEDIATELY to the settlement clerk (seated below the auctioneers on the auction stand) to pay for the unit. YOU CANNOT TEST DRIVE OR FURTHER INSPECT THE VEHICLE WITHOUT YOUR PURCHASER'S COPY!

LIGHT SYSTEM

RED LIGHT – “AS-IS”

SOLD AS-IS WITH NO DRIVE. SUBJECT TO ALL DEFECTS OTHER THAN LISTED BELOW. MUST BE SETTLED FOR IMMEDIATELY (EXCLUDES REGISTERED DEALERS). THE FOLLOWING MUST BE ANNOUNCED ON ALL VEHICLES. FAILURE TO DO SO IS CAUSE FOR ARBITRATION AND/OR REJECTION:

- *FLOOD, POLICE, OR FIRE CAR
- *R-TITLED VEHICLES
- *VEHICLES W/CRACKED BLOCK
- *ANTIQUES
- *FAULTY STEERING/BRAKES
- *GEAR SLIPPING OR MISSING
- (IF DETERMINED UNSAFE TO DRIVE)
- *DAMAGED/RUSTY FRAME
- *MISSING AIRBAG
- (EVEN IF REPAIRED)

GREEN LIGHT – “WITH DRIVE”

VEHICLE SOLD TO BE MECHANICALLY SOUND, FREE FROM ALL DEFECTS NOT ANNOUNCED. AUCTION POLICY ON ARBITRATION APPLIES TO RED AND YELLOW LIGHT SALES ONLY. **GREEN LIGHT SALES ARE NOT ARBITRATED BY AUCTION AS BUYER CAN REFUSE SALE FOR ANY REASON IF NOT SATISFIED (PRIOR TO TITLE TRANSFER).**

YELLOW LIGHT - “CAUTION”

VEHICLE HAS ANNOUNCED DEFECT. VEHICLE CANNOT BE REJECTED FOR ANY ANNOUNCED DEFECT.

BLUE LIGHT – “TITLE ABSENT”

ASSIGNABLE TITLE DOES NOT ACCOMPANY VEHICLE. MAY REQUIRE UP TO 14 DAYS FOR BUYER TO RECEIVE TITLE. VEHICLE CANNOT BE RESOLD OR LICENSED UNTIL TITLE RECEIVED. VEHICLE CANNOT BE REMOVED FROM PROPERTY (UNLESS REGISTERED DEALER). BUYER CHECKS ARE DEPOSITED IMMEDIATELY. SELLER CHECKS ARE HELD BY THE AUCTION UNTIL TITLE IS RECEIVED. AFTER 14 DAYS BUYER MAY REQUEST FULL REFUND AS LONG AS VEHICLE IS IN EXACT CONDITION AS TIME OF SALE. AUCTION MUST BE NOTIFIED 24 HOURS PRIOR TO THE RETURN OF ANY UNIT. THERE IS A \$10 FEE TO THE SELLER ON ANY UNIT SOLD BLUE LIGHT.

ARBITRATION POLICIES

ANY ARBITRATION MUST BE BEFORE 12:00 NOON THE DAY FOLLOWING THE SALE AND IS AVAILABLE ON RED AND YELLOW LIGHT SALES ONLY!!!
ARBITRATION RESULTS WILL BE DETERMINED BY AUCTION PERSONNEL, AND ALL DECISIONS ARE FINAL!!!

YOU MAY NOT REJECT ANY VEHICLE FOR THE FOLLOWING REASONS:

1. VISUAL DEFECTS (RUST, BROKEN GLASS, TORN UPHOLSTERY, ETC.)
2. DEFECTIVE ACCESSORIES (AIR CONDITIONING, RADIO, HEATER, ELECTRICAL EQUIPMENT, POWER EQUIPMENT, ETC.)
3. SMOKING OR BLOW BY
4. OIL, WATER, COOLANT OR GAS LEAKS
5. VALVE OR ENGINE NOISE
6. BACKLASH IN REAR
7. EXHAUST LEAKS
8. DEAD BATTERY / FAULTY ALTERNATOR

AUCTION WILL NOT ARBITRATE ANY VEHICLE SOLD “GREEN LIGHT” AS BUYER MAY REJECT VEHICLE FOR ANY REASON BEFORE TRANSFER OF TITLE. NO REJECTION AFTER TITLE HAS BEEN TRANSFERRED.

SERIAL/VIN NUMBERS

VEHICLES WITHOUT PROPER VIN VERIFICATION WILL NOT BE RAN! VIN MUST BE EMBOSSED ON VEHICLE OR I.D. PLATE. VIN STICKERS ARE NOT ACCEPTABLE, UNLESS STATE ISSUED VIN STICKER (I.E. HOMEMADE TRAILER, ETC.).

SELLERS

*ENTRY FEES MUST BE PAID & ODOMETER FORM COMPLETED BEFORE VEHICLE CROSSES BLOCK.
*SELLERS MUST HAVE STATE ISSUED PHOTO I.D.
*IT IS THE SELLER’S RESPONSIBILITY TO BE SURE THE CORRECT LIGHTS ARE LIT, AND THE CORRECT INFORMATION IS ANNOUNCED.
*TITLES WITH THE FOLLOWING DEFECTS MAY BE REJECTED: ALTERATIONS; ERASURES; IMPROPER REASSIGNMENTS; JUMPING SIGNATURES; MISSING FORMS.
*ALL SELLERS ARE PAID BY AUCTION COMPANY CHECK REGARDLESS OF HOW AUCTION HAD BEEN PAID BY BUYER
*REGISTRATIONS AFTER 7PM WILL BE CHARGED AN ADDITIONAL \$10.

BUYERS

*ALL VEHICLES MUST BE PAID IN FULL SALE NIGHT. BUYERS ARE RESPONSIBLE FOR ALL TAX AND TITLING FEES.
*ALL VEHICLE TITLES MUST BE TRANSFERRED WITHIN 6 DAYS, AND NO VEHICLES ARE ALLOWED TO LEAVE THE PROPERTY UNTIL THE TITLE IS PROPERLY TRANSFERRED.
*BUYERS ARE RESPONSIBLE FOR THE FEE FOR A FULL TITLE. TITLES LOST IN THE MAIL WILL BE AT THE EXPENSE OF THE BUYER.
*ALL TITLE WORK WILL BE SUBMITTED TO PA DEPT. OF TRANSPORTATION BY AUCTION. NO TITLE WORK WILL BE CARRIED OUT BY THE PURCHASER-THIS IS THE LAW!!!
*CASH, CREDIT CARDS, AND PA CHECKS (WITH 2 FORMS OF ID, ONE OF WHICH MUST BE A VALID PA DRIVER’S LICENSE) ARE ACCEPTED AS PAYMENT. ONLY PA CHECKS ARE ACCEPTED. ALL CHECKS ARE ELECTRONICALLY APPROVED.
